highlights**

To celebrate the tenth anniversary of our network, we will hold a special roundtable session that answers the question ‘*What happened to pro-poor growth?*’. The speakers in this session will include James Thurlow (IFPRI) who will share his views on pro-poor growth in Zambia, Sarah Ssewanyana who will discuss Uganda’s experiences with integrating pro-poor growth into its national growth strategies, as well as Georg Schäfer (GIZ) and Carlos Rodríguez Castelán (World Bank) who will both share their experiences from practice.

Promoting Pro-Poor Growth in the Run-up to 2015: What Are the Critical Challenges and Policy Issues? was the theme of the first PEGNet workshop thus we decided to dedicate a special session to discussing

In addition to the discussion on pro-poor growth, we will also have a roundtable discussion on ‘*Economic transformation and rising inequality*’.

As usual, we will have a keynote speech



on each conference day. Margaret Mcmillan from Tufts University and IFPRI, will share her

expertise on industrialization and structural change on the first conference day.

Oiendriila Dube from New York University



will talk about her work on the political economy of development on the second conference

day.

We also have a very interesting line up of poster and paper presentations set up for the conference. The PEGNet Best Practice Award will be awarded for the seventh time this year to a project that effectively demonstrates cooperation between development research and practice.

3. News from 3ie

Over the past decade the Government of Uganda has made improvements in public sector performance measurement and financial management. Nevertheless, evaluation of public policies is still rarely used. In order to

address this evidence gap, the

Government of Uganda launched a National Monitoring and Evaluation Strategy. The goal of the 3ie fund is to enable selected research teams to carry out a process or formative evaluation of a program on which the main findings are based on.

Therefore, 3ie invites submission of proposals for process and formative evaluation of Government of Uganda's programmes and policies in the areas of family planning, youth livelihoods, public service delivery and local governance and universal primary education. The deadline for submission is the **24th August, 2015**.

The key goal of the 3ie's bursary program is to support the capacity building in

conducting and using high quality impact evaluations and systematic reviews. It is important to find policy relevant evidence. However, 3ie is offering eight bursaries for the Evaluation Conclave to be held from 23rd till 27th November 2015 at Kathmandu, Nepal. To be eligible, applicants must be nationals residing in a low- or middle-income Asian country and be actively engaged in the field of impact evaluation. The deadline for submission is the **14th August, 2015 (12 GMT)**. [>>More information](#)

workshop will take place on the 26th and 27th November in Paris, France.


Its central goal is to give PhD students in Development Economics an opportunity to

5. News from GIZ

GIZ's Sector Project "Employment Promotion in Development Cooperation" has published "Guidelines for an Employment and Labour Market Analysis (ELMA)". ELMA provides a methodological and tried-and-tested tool for a comprehensive analysis of the labour market and employment situation. Furthermore, the Sector Project has published "A Systematic Framework for Measuring Employment Impacts of Development Cooperation Interventions", which is available [here](#).

Moreover, GIZ's Sector Project "Sustainable Economic Development" has published a new study on "Benefits of a Green Economy Transformation in Sub-Saharan Africa". The study provides a comprehensive account of green economy benefits (economic, social and environmental) for Sub-Saharan African countries as well as key

GIZ and UNIDO have launched the Enhancing the Quality of Industrial Policy Toolbox (EQuIP). The EQuIP toolbox enables developing countries to independently develop evidence-based structural and industrial policy.
