

The PEGNet Conference 2013 was held on October 17 and 18 in Copenhagen, Denmark at Bispetorvet, University of Copenhagen. The conference attracted a mix of researchers, policy makers and development practitioners working on environmental sustainability, green growth and poverty reduction.

The fifth Best Practice Award was awarded to the U-ACT project which is collaboration between ETH Zurich (Switzerland), the Federal Institute of Aquatic Science (EAWAG), (Switzerland), Makerere University (Uganda) and NGO SSWARS (Uganda).

Employment strategies in the Developing World - How to create sufficient, productive and decent jobs

Zambia Institute for Policy Research and Analysis (ZIPAR), Lusaka, Zambia

September 18-19, 2014

According to ILO estimates, 900 million people are poor despite being employed, 200 million people are unemployed and 75 million of them are young people in the age between 15-24 years. Global youth unemployment has grown at an alarming rate affecting not only the developing world but the developed world as well. In Sub-Sahara Africa, the incidence of youth unemployment is estimated at over 20 percent. With the population becoming more youthful and with increasing unemployment rates; the most critical question that emerges for developing countries is how to create jobs in order to avert a looming crisis that is feared to have a potential of sparkling protests. High youth unemployment rates are only part of the picture. In many developing countries, a large share of the working age population is in informal entrepreneurship and small scale agriculture with no social securities. These people are at higher risk in case of illness, job insecurity and weather and climate related events.

We consider employment to be a highly relevant issue for research as well as practice. There is a large demand among policymakers for strategies and methods that analyze the employment needs of different countries; particularly since these countries are confronted with various problems which do not allow for one-size fits-all strategies. The employment creation policy goals significantly differ across countries. For example, while countries in the MENA region require policies that address the high rates of youth unemployment, countries like China need policies that to manage the vast number of migrant workers in their countries. Thus strategies employed need to be context specific; since a strategy that focuses on the expansion of low skilled labour demand may be useful for countries in Sub

Saharan Africa with high levels of unskilled labour, but will not be helpful for countries in the MENA region that have an excessive supply of well-educated young university graduates.

In particular, but not exclusively, we invite contributions (papers and presentations of projects) that provide solutions to the following challenges and questions:

- Most people in developing countries are dependent on the agricultural and informal sectors. We question whether employment creation should concentrate on these sectors or focus on dynamic sectors with innovative potential and possible productivity gains such as tourism, manufacturing and technology?
- Thinking about future employment means thinking about education today. We examine how education at schools, universities and in vocational training van be improved to provide better skills for future labour market demand?
- In many developing countries the education and training of young people is not oriented towards the needs of the labour market. We question how - general as well as vocational and technical - education and training systems can be reformed in a way that best serves the employability of young people and their integration into the labour market?
- Which options exist to improve the labour market information and job matching systems?
- Are subsidies for an apprenticeship system and the recruitment of young people a viable option to promote youth employment in a sustainable way?
- What are the experiences in the field of youth employment creation in developed countries? To which extent might they be relevant for developing countries and emerging economies?
- How can the impacts of selected employment creation policies and instruments on youth employment be measured?
- Are social safety nets a viable means of cushioning the effects of unemployment in developing countries?
- How can we enhance the growth of viable and sustainable enterprises in rural and urban areas?
- What are some of the country specific policy responses and job creation strategies that could be useful in addressing unemployment?
- Should informal enterprises in developing countries be (quickly) formalized and if yes how?

Panel Proposal

Compared with other countries, in particular the US and UK there is limited active cooperation between researchers and development practitioners in most European countries. Development agencies and NGOs are separated from academia both personally and in the details of the topics they are interested in. The current evaluation boom would however provide exceptional opportunities for greater integration of research and practice in program design, implementation and evaluation. While there are many reasons for this separation, this session will concentrate on learning from successful examples.

This session will convene cases of outstanding cooperation between development economists and development practitioners. The case studies come from different fields (potentially cash transfers, insurance, health, and water) and will be presented on the basis of one of the academic papers that resulted from the project. This is followed by an open discussion and a moderated discussion that will focus on the lessons learnt from the projects presented. PEGNet will present the results from studies conducted in Germany on the research demand by development practitioners and the importance of policy relevance by researchers.

The aim of the session is to use successful examples in order to better understand how to improve cooperation between academia and development practitioners in program design, implementation and evaluation.

10. News from 3ie

The International Initiative for Impact Evaluation (3ie) recently released a new report and policy brief. The new report reviewing evidence of what works in education in developing countries shows that education interventions are not only getting more children into school and keeping them there but are also helping children to learn more. [Link to the report] The policy brief produced in collaboration with the IDS Knowledge Services, draws out policy recommendations from the report and provides direction for programme design and implementation. [Link to the policy brief]

Moreover, 3ie is requesting qualifications for an impact evaluation of the contribution of the removal of user fees on universal health coverage in eastern, central and southern Africa region implemented by the East, Central and Southern Africa Health Community (ECSA-HC). The evaluation will examine the extent to which the ECSA-HC policy on the removal of user fees has contributed to universal health coverage in two to three countries in that region.
