1. Announcement: PEGNet bids farewell to Linda Kleemann

After 6 years as PEGNet Managing Director, Linda Kleemann will be leaving the network to pursue a new opportunity in development consultancy. Linda joined PEGNet in January 2009 and quickly developed herself into an invaluable member of the PEGNet Team. Linda coordinated the 2009 to 2013 PEGNet conferences, organized workshops on various themes and managed the network's daily activities which resulted in the subscriptions to the network reaching over a thousand.



Furthermore, Linda undertook many innovative activities such as the preparation of surveys on the demand for research among development practitioners and as a follow up, a survey on the demand for policy advice from researchers. During her time at PEGNet she also completed her doctoral studies at

the University of Kiel where she analysed the organic certification, sustainable farming and return on Investment of pineapples using empirical evidence from Ghana.

Linda will continue to actively contribute to PEGNet in her new role as external consultant and advisory board member.


2. Announcement: Call for Best Practice Award submissions

This year, PEGNet will grant its Best Practice Award for the seventh time to an initiative that has demonstrated best practices in cooperation between researchers and practitioners in development cooperation. The idea of the Best Practice Award was born out of two observations: On the one hand, the policy impact of research is often weak. On the other hand, modern research tools seldom make their way into policy design indicating a lack of shared knowledge. If there is a project which fits the requested criteria and is a good example of how you can close the gap between researches and practitioners, we would

GIZ's Sector Project ‘*Sustainable Economic Development*’ has published a new study on “*Sustainable Economic Development in Resource-Rich Countries – Guidelines for Technical Cooperation*”. The guidelines present tried-and-tested approaches of Technical Cooperation that can support cooperation countries in addressing the economic potentials and challenges of resource abundance. The document serves as a tool for TC practitioners with regard to the appraisal, commissioning,

The German Development Institute (DIE), and the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) together with the International Center for Sustainable Development (IZNE) at the Bonn-Rhein-Sieg University of Applied Sciences welcomed about 55 international participants to join the international workshop on *“Measuring the social, economic and political effects of social protection: How to overcome the challenges?”* held on **15th -17th April 2015** at the DIE premises in Bonn, Germany.

It provided a platform for exchange and mutual learning among academics, policy-makers, and experts from public entities to discuss the challenges of measuring effects of social protection, and learn the various approaches to tackle them. Participants came from 17 countries in South- and South East Asia, Latin America and Europe; among them representatives from Ministries such as Indonesia, Vietnam, Chile, Mexico, Peru, as well

The German Institute for Development Evaluation (DEval) has announced two vacancies for Heads of Departments. The main tasks of the Heads of Department would be to design the scope of duties, ensure that project steps are met according to the agreed schedule, evaluating the final results and supporting the institute's strategic position. Applicants should have completed their PhD in economics, social science, or any other relevant science. They should have a working knowledge of evaluation methods and qualitative and quantitative

methodological approaches of social science as well as good analytical skills. Furthermore, they should have working knowledge of evaluation processes and procedures in contract law and public procurement law. The deadline for applications is the **10th May 2015**.
