1. PEGNet Tenth Anniversary

PEGNet

Our annual conference was held in Berlin on October 8 and 9. It addressed the theme 'Transformation of Developing and Emerging Economies: Challenges and Opportunities for Inclusive and Sustainable Growth'.

The conference attracted nearly 130 researchers, policy makers and practitioners working in development economics. Based on the **feedback**, the keynote talks given by Margaret McMillan and Oeindrila Dube were among the highlights of the conference this year. The plenary session that discussed the 'Economic transformation and rising inequality' as well as the roundtable discussion that sought to answer the question 'What happened to pro-poor growth?' were equally popular.

Our media partner, D+C has published an article that highlights the keypoints raised in the roundtable discussion on 'Economic transformation and rising inequality'. This article is available **here**. In addition, a blog piece has been written that questions the motivations of young scholars working on development research. The author asks whether theoretical modelling and statistical significance have taken over policy and practical relevance in research. This year, Micheal Grimm from the Universities of Passau and Erasmus Rotterdam and Luciane Lenz from RWI Essen, received the **PEGNet Best Practice Award** on behalf of the Institute of Social Studies, Erasmus University Rotterdam, Rheinisch-Westfälisches Institut für Wirtschaftsforschung, Essen and the Policy and Operations Evaluation Department (IOB) of the Netherland's Ministry of Foreign Affairs for their project titled 'Impact Evaluations of Access-to-Energy Interventions Supported by the Netherlands'.



The project successfully convinced the jury that they had achieved effective interaction between research and practice bv presenting results from several impact evaluations that assessed a series of energy interventions ranging from improved cook stoves and solar home systems in Burkina Faso to grid electrification and the

distribution of Pico-PV lamps in Rwanda.

As in previous years, conference participants attending the dinner were encouraged to pay a commitment fee of 20 Euros to prevent food wastage. We would like to thank the conference participants for raising a total of **1140 Euros** from this fee. This money will be donated to the 'Zentralen Bildungs- und Beratungsstelle für Migrantinnen in Schleswig-Holstein, ZBBS e.V. in Kiel'.

The ZBBS is an NGO that safeguards the rights and well-being of immigrants and refugees and assists their integration within their new environments. It specialises in providing free counselling and language courses for immigrants and refugees that have recently migrated to Kiel. More information on the organisation is available **here**.

2. Launch of PEGNet Policy Brief Series

The new PEGNet Policy Brief series will provide information and key policy recommendations on topics that fall within

3. News from DIE

The German Development Institute (DIE) has received a grant from BMZ's initiative to combat hunger (**Sonderinitiative Eine Welt Ohne Hunger, SEWOH**) to conduct research and policy advice on how development cooperation can contribute to increase food security in the rural areas of Sub-Saharan Africa (**SSA**). The DIE



project has eight work packages ranging from overarching topics (conceptualizing heterogeneous rural population with differentiated development potentials and support needs; results based aid;


food security interventions in fragile countries) to more focused ones looking at innovative issues: agricultural growth corridors, sustainable agricultural technologies, public-private-partnerships in irrigation, social protection. It is explicitly acknowledged that the rural population is not homogeneous and has differentiated development potentials and support needs (rural worlds), and that interventions have to be combined into broader strategies for inclusive rural development.

The German Development Institute (DIE) and the UNEP Inquiry into the Design of a Sustainable Financial System are organising a conference on ,The Role of Financial Governance in Greening Financial Systems' in Berlin on **9**th **November 2015**.

On the occasion of the International Day for the Eradication of Poverty on October 17th the Sector Project


Eradicating Poverty - Reducing Inequality invited renowned experts to discuss chronic poverty, inequality as well as how to tackle the ultra-poor.

David Hulme, Professor at the Manchester University and Director of the Brooks World Poverty Institute, talked about the 2030 Agenda for Sustainable Development and its first goal on ending poverty in all its forms everywhere until 2030.

Prof. em. Richard Wilkinson presented his research on inequality and why lower levels of inequality leads to better outcomes for society, in particular in terms of health. Last but not least, Marion Lieser, Director of Oxfam Germany, discussed with GIZ colleagues, whether new approaches to tackle inequality are necessary.

GIZ's Sector Project Sustainable Economic Development has published a new discussion paper titled `Synergies

and trade-offs between growth policies and areen inclusiveness' authored by Anna Pegels from the German Development Institute (DIE). The discussion paper starts by offering both a theoretical background and definition of inclusive green growth, and then provides guiding questions to identify and investigate social consequences that may arise from green growth policies. 5. News from DEGRP

The DFID-ESRC Research Programme (DEGRP) has recently launched a new set of policy essays examining

economic transformation in Tanzania. Based on findings from a high-level conference held in Dar es Salaam in February this year, it includes contributions from DEGRP researchers on topics such as agriculture and microfinance, as well as a keynote speech from the Governor of the

Bank of Tanzania, Professor Benno Ndulu. The essays are available **here**.
