1. Announcement: Registration for the PEGNet conference is now open

The registration for the PEGNet 2016 Conference on "Regional integration for Africa's economic transformation – Challenges and opportunities" is now officially open and can be accessed here: >>Registration form.

Similar to previous years, there will be no registration or conference fees. If you want to attend the conference dinner on the first day of the conference day, a fee of 20 Euros or 15,000 Rwanda Franc will be charged. This fee will be charged to ensure that participants that have signed up for the dinner are committed to attending it and to reduce food wastage. The money collected will not be kept by the PEGNet team but will be donated to a charity whose mission is in line with that of PEGNet and takes a strong focus on the reduction of poverty and inequality. Details of how to make the payment will be shared upon completion of the registration form. We are happy to invite you to attend this conference in Kigali.

As in previous years, we have a very exciting line up of speakers and sessions. The roundtable discussion on "Harnessing regional trade for growth and poverty reduction in landlocked countries" will be chaired by Ms. Sonja Kurz who currently heads the section on Economic Policy and





Private Sector Development at the GIZ Headquarters in Eschborn, Germany. Ms Kurz will be joined at the roundtable discussion by Mr Ed. Brown from the African Center for Economic Transformation (ACET), Ms. Xinshen Diao from the International Food Policy Research Institute (IFPRI) and

Mr. Denis Karera who is the Chairperson of the East Africa Business Council. The Rwandan Minister of Trade and Industry, Hon. Minister Mr François Kanimba will also be participating in this discussion. The diverse backgrounds and fields of expertise of the speakers that range from agricultural economics, industrialization, regional integration to structural transformation are guaranteed to yield important insights.

2. New Policy Brief

The fourth PEGNet Policy Brief has been published and is now available on our website at the following link: **PEGNet Policy Brief**. The Policy Brief on 'Migration,

Poverty and Equality' that has been authored by Lykke E. Andersen, proposes that reducing barriers to migration would not just reduce global inequality, but could also bring about trillion dollar benefits to the world economy and help overcome projected labor supply and demand mismatches caused by the rapidly ageing populations in rich countries. Lykke E. Andersen is currently based in Bolivia where she



directs the Center for Environmental-Economic Modeling and Analysis (CEEMA) at INESAD.

3. News from the European Association of Development Research and Training Institutes (EADI)

The EADI General Conference is a joint partnership between the EADI (European Association of Development Research and Training Institute), NFU (Norwegian Association of Development Research) and the University of Bergen.

This conference is organized every third year, with the most recent conference held in Bonn 2014. In the Nordic context, a biennial Nordic Development conference is organized by one of the respective national development research associations, the most recent one held in

Gothenburg in 2015. In 2017, EADI and NFU join forces together with the University of Bergen as the local host to invite scholars, policymakers and practitioners to a three-day conference (21-23 August 2017) to engage in new



approaches to understand global challenges. Therefore, next year's conference is organised under the heading "Globalisation at the crossroads: rethinking inequalities and boundaries".

News from DFID-ESRC Growth Research Programme (DEGRP)

DEGRP has recently published its latest set of policy essays based on discussion at a DEGRP event held in

Growth Research Programme Johannesburg last December, in parallel with the second summit of the Forum on China-Africa Cooperation (FOCAC).

Featuring contributions from DEGRP China-Africa researchers, as well as a keynote speech from ex-World Bank Chief Economist

Yifu Lin, it addresses issues such as industrialisation, employment dynamics, conservation, governance, and peace and security, all in the context of changing China-Africa relations. Download the set of essays here. A Mandarin version is coming soon.

Another issue is DEGRP's latest 'Research in Context' by Steve Wiggins which provides context and analysis for DEGRP-funded project Assesing the contribution of the dairy sector to economic growth and food **security Malawi**. The project used supply chain analysis to assess the potential for dairy to aid economic growth and food security in Malawi.

In its ongoing efforts to evaluate developpp.de, Germany's flagship programme for private sector cooperation in international development, the German

Institute for Development Evaluation (DEval) has published a portfolio analysis of projects implemented to date under the auspices of the programme. Results factors influencing application and

selection of projects are available both as a summary version (in English) as well as a full report (in German). Publication of the final evaluation report is scheduled for later this year.

The GIZ Sector Project Development-oriented Trade Policy, Trade and Investment Promotion has published a paper on 'Monitoring regional economic integration in practice'. Since the 1980s the world has witnessed an increase in regionalism resulting in an increasing number of regional trading blocs and the establishment of regional economic communities (REC). Regional economic integration is believed to bring a number of benefits. Amongst them ranges economic growth through trade in larger markets which is believed to

result in prosperity for the population and is considered to positively influence stability. With a growing number of RECs and regional free trade agreements (RTAs), the question arises, whether regional economic integration has been achieved and whether the assumed benefits hold true. The objective of the paper is to establish an overview of currently existing monitoring and evaluation approaches and systems within a number of RECs worldwide to measure the progress and attainment of regional economic integration (REI). The section Rural Development Theory and Policy of the Institute of Agricultural Sciences in the Tropics (Hans-Ruthenberg-Institute) offers a position as "Research Associate", that is available from 1 September, 2016 or

later for a period of 33 to 36 months as Research Associate.

The research associate is expected to contribute to the teaching, administration and research activities of the professorship. The successful candidate will also pursue own empirical research for a doctoral degree in the field of rural development economics. The topic chosen could be linked with on-going or newly funded research projects. Candidates may also propose their own dissertation topic and research plan in a brief (maximum two pages) proposal.

Candidates should have a good or very good degree (at the Master's Level) in agricultural, development or environmental economics, or other related fields in economic or social sciences, and a keen interest in research on agricultural and rural development. M.Sc. level courses in statistics/econometrics are an additional prerequisite, and solid practical skills in using STATA and/ or SPSS are expected. In addition, skills in qualitative and/or quantitative research methods and experience working in developing countries or with national and international development organizations are welcome. A very good working knowledge in the English language is required, and other languages (in particular French or

Spanish) are as well an advantage.

The University of Hohenheim strongly encourages women to apply. Applications including a CV, the M.Sc. and B.Sc. transcript with listing of courses and grades, full PDF copies of the Bachelor and Master thesis plus list of publications and presentations, together with a cover letter shall be sent by **15 August, 2016** to: Prof. Dr. Manfred Zeller (**email**). Postdoctoral Researcher in Development Economics. The position has a duration until December 2017. An extension of the contract may be possible.

The researcher will play a lead role in research projects related to development economics with a focus on economics of food and nutrition security, and opportunities of web based information and communications. The researcher will be based at ZEF in Bonn, Germany, and work in collaboration with the ZEF research team on food price volatility. He/she will be responsible for different kind of tasks, for example conducting research on determinants of volatility and risks or teaching in the ZEF doctoral studies program.

Applicants should have an PhD in Economics, Development Economics, or Agricultural Economics or related, a promising academic publications record, very good analytical skills for quantitative and time series econometric analysis, excellence in oral and written English language, excellent interpersonal skills and team spirit and knowledge in statistical packages such as STATA

MOVAAR holds the youth of communities in developing countries as their most powerful capability and places them at the heart of our mission to help enlarge opportunities for self and community betterment in education, grassroots entrepreneurship and small enterprise, and local leadership.

To reach this goal M.O.V.A.A.R. uses project based learning in the Gambia to enhance the skillset of high school students and enable them to fully develop their entrepreneurial potential. The pillar of MOVAARS activities is the Skills Formation Program (SFP) which is a 12-week (52 hours) skills-transfer program.

After a successful pilot project and second edition, the SFP program will be expanded to Sub-Saharan Africa.
